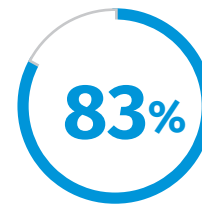

- › The journey through the digestive system

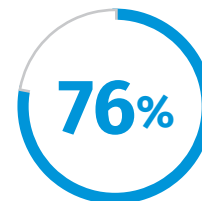
Many probiotics, such as those used in yogurt, are vegetative (ex. *Lactobacillus* and *Bifidobacterium*) and just can't survive these stresses.



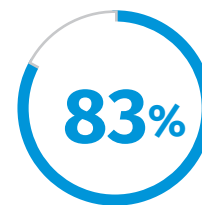
